### PERB Hearings Continue

On Tuesday, March 10, Peace Officers of California will finish presenting their witness testimony in front of the Public Employment Relations Board. POC has been allotted five days to present their case in front of Judge Shawn Cloughesy. CSLEA and DPA will also be allotted five days each to make their case, though it is unknown how much of that time will be used. The lineup of witnesses for Tuesday's hearings should prove compelling, and includes:

- Warden Bob Orange, the immediate past President of POC
- Mike Lilly, Supervising Special Agent, Department of Justice
- Tim Fries, former CSLEA (then known as CAUSE) lobbyist
- Alan Barcelona, President of CAUSE/CSLEA for the last 15 years

The hearings are open to the public with limited seating available – anyone attending the hearings is asked to comport themselves as any professional peace officer would, with respect given to the Judge and the proceedings. Testimony begins at 9:00am.
