Complainant requests that PERB formally notify CSLEA that they are in gross violation of the Dills Act; 3519.5 (b) and that the CSLEA Constitution & Standing Rules do not supersede state law. Complainant also requests that PERB order CSLEA and its agents to cease and desist in any derogatory or demeaning comments/statements, penalties, disciplinary hearings, suits, harassment, or any such actions deemed to be harmful or negative to the complainant. Due to the widespread and encompassing illegal reprisal being conducted by CSLEA against employees; complainant requests that this order also apply to any other employee being similarly harassed or subjected to reprisal for their support, vote, or work with Peace Officers of California in this completely legal severance issue being conducted within the purview of PERB. The order should read, that CSLEA shall incur all expenditures of money to the Complainant / Defendant, which I / they have incurred, including but not limited to: Legal Fees / Consultations, Food and lodging, postage, and all mileage cost associated or related with the defense of these allegations.
